**QUALIFICATION OF LARGE WIND POWER GENERATING PROJECTS**

**Invitation for Qualification (IFQ)**

1. This Invitation for Tender follows the intention of the Government of the United Republic of Tanzania through Tanzania Electric Supply Company Ltd (TANESCO) to competitively engage qualified applicants to develop some of the planned wind power projects with a total capacity of 200MW at different locations within Tanzania.
2. TANESCO intends to procure power generation from a set of wind power projects with total capacity of up to 200 MW from Singida, Njombe and Dodoma Regions. Projects should be completed between 2018 and 2020
3. TANESCO is therefore pleased to present this opportunity to prospective developers to undertake feasibility study, finance, build, own, operate and transfer wind power projects of capacity of not less than 50 MW. Note that no more than 100MW capacity shall be connected in one substation.
4. Tendering will be conducted through International Competitive tendering procedures specified in Regulation 119 of the Public Procurement (Regulations– Government Notice 446 of 2013, and is open to all Applicants as defined in the Regulations. Prospective developers who have earlier expressed their interests to develop wind power projects by way of concept note, MoU or any other form and have submitted documents to TANESCO are advised to participate in this tendering process.
